The UEMS-EACCME® is delighted to inform you that exhibit opportunities will be available during the *Fifth UEMS Conference on CME-CPD in Europe* to be held on Friday 11th and Saturday 12th March 2022 in Seville (Spain). As space is limited, we offer all companies the same option. Exhibits can be set up on Thursday early evening and will remain for the duration of the meeting to ensure maximum exposure. The exhibit will be located in the meeting foyer right in front of the plenary session room.

Costs for an exhibit space are 1650 EUR. This cost includes:

- Own exhibit unit / display with maximum size of 2.50 mtrs x 1.50 mtrs
 - Note: any promotional banners, displays or other exhibit materials cannot exceed 2.00 mtrs high (due to limited ceiling height of the area)
- Exhibit includes 1 free conference registration
- Recognition of the exhibitor in printed meeting materials and online

Based on interest, an exhibit floorplan will be distributed where spaces can be selected on a first come, first served basis.

Terms and Conditions

The space assigned is to be used solely by the exhibiting company as agreed with organisers and it is agreed that the exhibitor will not sublet or assign any portion of same. When you agree to exhibit, you automatically agree to comply with below conditions.

Liability

The exhibitor is liable for any damage, destruction or alteration of the hotel facilities and equipment, accidentally or voluntarily caused by his guests or subcontractors. This includes any activity that can cause damage to the hotel properties such as partitions, walls, ceiling, carpets etc. including but not limited to usage of any adhesive, nailing, fire, hammering and smacking. In case of any damage or loss incurred to the property, the exhibitor must compensate with the amount equivalent to the property value.

It is the responsibility of the exhibitor for any valuable materials/equipment brought in to the hotel or meeting room and the hotel will not be held responsible for any loss or damage.

Conditions

Nothing should be done which will endanger the users of the building and the policies of insurance relating to it and to its contents. In particular:

- 1. Obstructions must not be placed in any gangways, corridors, stairways or exits. Fire exits must never be obstructed.
- 2. The emergency lights must not be covered as they illuminate when power has been cut to show exit signs and routes.
- 3. Fire-fighting apparatus shall be kept in the designated places and only used for its intended purpose.
- 4. Highly flammable substances shall not be brought into, or used, in any part of the premises
- 5. No decoration shall be erected or suspended from any part of the premises except by prior consultation with the written agreement of the Centre management. If such permission is granted, decorations must be erected clear of the walls so as to ensure no damage to the property in consequence thereof. No decoration of a flammable nature shall be erected or suspended on any part of the premises.
- 6. The use of naked flame, smoke machines, lasers and pyrotechnics are prohibited without the prior written consent of the Hotel Management.
- 7. The exhibitor shall keep the premises, fabric, furniture, fittings, and equipment in good condition and free from damage and shall take reasonable steps to ensure that damage shall not occur
- 8. No nails, screws, drawing pins, tape or staples may be used on the walls, woodwork, doors or furniture. Posters or placards may only be put up with the agreement of Hotel Management. The exhibitor shall be responsible for the use / safe keeping of his / her equipment, nor shall the exhibitor have any claim against the hotel for loss or damage.
