The emphasis of the near future will build on the work done through our network of Knowledge Brokers that we plan to revitalize and strengthen. Yet another big task to do is to create the requirements for the official dedicated website that should be compatible with the web portals of WP5 and WP6.

After sending out the survey on terminology and mobility mapping, the partner countries provided information via this survey tool. In this way we would like to thank to all WP4 associated partners who have completed the survey. WP4 is busy working on its analysis and on further clarification from the country information provider.


Beyond the survey, WP4 is going to contact more international experts in order to make interviews. One of the most important activities is to initiate discussion on WHO Code of Ethical Recruitment. Day after Bratislava Conference we held the first fruitful workshop on this activity with the participation of many countries representatives and international stakeholders. The Hungarian team also held the Stakeholder forum. The main aim of the forum was to raise awareness on the Joint Action project and to ensure the involvement of the Hungarian HWF planning and forecasting activities. The professional team and the stakeholders will continue collaboration on the development of HWF planning initiatives and activities and regular meetings and forums will be held in the future.

WP3 created an Evaluation tool and produced Evaluation reports on Risk and Issue Management, Minimum Data Set and List of Experts. Furthermore, team formulated an Evaluation tool on the Progress report, Stage plans and Sustainability strategy that was upgraded recently. Work that will be carried out in the upcoming period focuses on establishing the criteria for choosing the experts for the Expert Reference Group. Core team members, Marjukka, Andrew and Johanna are currently busy with creation of the evaluation tools for a number of deliverables including Technical recommendations for the sustainability of the JA, Recommendations towards policy making, User's Guidelines on estimated future needs and Report on Terminology mapping. We are very pleased to welcome on board Ms. Alisa Puustinen from University of Eastern Finland as part of the Work Package 3 core team.

WP4



Italian team was focused on delivering very important outcome of the project - D051 Minimum planning data requirement. The draft was analyzed and approved by the Executive Board in Vienna on December 13th with major changes. The fourth and last draft with major changes done, has been delivered on January 23rd, just before the Bratislava Conference. The final MDS was presented by Giovanni Leonardi during Plenary Assembly Meeting. Furthermore team is proceeding with the analysis of the existing literature, in coordination with WP4 and 6. Another challenge vet to come is preparation of the Expert group workshop that will be held in May in Florence. It is a pleasure to announce that some Italian regions has become Collaborating partners of the JA ready to provide their expertise in developing D054 Report on WP5 pilot study. The Italian and Portuguese team, with the supervision of the WP1, have defined a planning document to organize pilot study organization structure and the activities. This document has been discussed and approved, with minor changes, during the Pilot Study workshop held in Bratislava. In this respect two meetings have been fixed, with the aim of starting the collaboration between stakeholders and public entity of the two countries and visit the countries sites: the 7th of May in Florence and the 17th of June in Lisbon.



WP6





Work package 6 has had a busy past few months preparing for the recently held workshop in London (10-11th February). We felt the workshop was a success, with partners engaging in lively discussion and debates. WP6 are currently creating a list of actions which have come out of the workshop and will be sharing them with partners shortly. Looking ahead WP6 will be focused on assisting and organising the conduction of Horizon Scanning interviews across member states as a result of the training partners received at the workshop. We will also be moving forward with the development of our toolkit and guidelines, with input from partners in the next few months.

Work package 7 focused on their priorities which was primarily upgrade of the Sustainability strategy, developing List of Experts and conduction of Stakeholder interviews.

List of Experts, as one of the core outcomes of this work package, is vet another deliverable reaching development as was presented on JA Conference in Bratislava, We have now specified the levels and main areas of competence as the criterion for project expertise. On this basis we can consequently edit the existing List of Experts on the basis of chosen criteria. Stakeholder interviews were vet another important tool to help us in creating stronger cooperation with our stakeholders and provide us with essential information and input for further WP7 recommedations. WP7 with support of the programme manager are in progress on interview conduction. After the interviews are carried out, the team will elaborate the results and we will share them with you.
