


... and appraisers are supposed to ask for any supplementary information in case they feel this extra information is needed for the appraisal ...


... during an appraisal it is important to observe as much as possible ...




... and appraisers are supposed to write down in their notes everything they see and hear during this observation while remaining on the background ...








... in order to evaluate whether the appraised examination is based on clear questions, has a fair selection process and is free of misunderstanding ...



... evaluation of personal experiences is also very crucial in appraisals ...



... and as a result appraisers will try to look for spontaneous opportunities to speak with candidates and examiners participating in the exam ...



... all of these elements of appraisal will allow the UEMS-CESMA Observers to write a clear and comprehensive appraisal report on the examination ...



... which will be returned to the organisers upon payment of the UEMS-CESMA Appraisal invoice and reimbursement of costs to appraisers ...



... in case no major remarks have been formulated by the UEMS-CESMA Observers, a diploma will be awarded with a validity period of 5 years.

The European Council for Accreditation of Medical Specialist Qualifications

Since its creation in 1958, the UEMS ambition is to promote patient safety and quality of care through the development of the highest standards of medical training and health care across Europe. The UEMS is addressing these issues through the harmonisation of medical specialists' qualifications

In line with its Strategy adopted in 2008, the UEMS established the European Council for Accreditation of Medical Specialist Qualifications (ECAMSQ®) with a view to assess the competence of European medical specialists according to these high standards of medical training. When fully implemented, this competence-based approach aims to achieve a common background for the assessment and certification of medical specialists' competence all over Europe, based on the core curricula developed by the Specialist Sections of the UEMS.

Key points

- These are Standards on how a good exam should be organised & run
- Scope is limited to exams not the whole of assessment
- Without detailed Standards it is not possible to assess / appraise an examination
- Once Standards are in place, and appraisals are being undertaken effectively, the process should be termed Accreditation

- Make document more accessible
- Reconsider criteria for admission to UEMS examinations and award of Diplomas / Fellowship

Next steps with milestones

- Further updates in light of comments received and discussion at CESMA 23 meeting (Brussels)
- Slim down document, transferring guidance elements to procedural document
- Prepare for final approval by CESMA membership Feb-Mar 24 and ratification May 24.
- Submit to UEMS Council Autumn 2024
