CONFERENCE ON EUROPEAN TRAINING REQUIREMENTS (ETR)

Introduction and organisation of the Conference

The conference will be held in Brussels, on Thursday April 20th 2023, the day before the UEMS Council meeting.

The content of the conference would include general educational medical topics and topics related to the three-part structure of the ETR: trainees, trainers and training institutions.

It is expected that the conference will confirm essential role of UEMS and ETRs in the highest level of medical education, which is postgraduate specialty training. It is based on the long tradition of UEMS that started with the Charter on Training of Medical Specialists in the European Community (1993) and Chapter 6 which then developed into the ETR in which many UEMS sections & boards as well as all executives devoted a lot of effort to raise the standard in European postgraduate specialist education following at the same time the great advancements in the field of medical education.

UEMS ETRs are conceptualised and composed aiming to apply and advance the principles of Competency Based Medical Education (CBME). However, the experience of the ETR Review Committee shows that some parts of the newly proposed ETRs do not follow the proposed CBME values presented in the items designated in the ETR template structure. In the same time the thoroughly evaluated/reviewed and approved ETRs may encounter various challenges in implementation.

Proposed is a process/implementation type of evaluation, which determines whether programmes activities have been implemented as intended and resulted in certain outputs. The STUDY ON THE IMPLEMENTATION OF THE EUROPEAN TRAINING REQUIREMENTS (ETR) IN THE UEMS MEMBER COUNTRIES will be conducted based on the Questionnaire that will be sent to the member countries about the implementation of ETR related to the specific requirements that are presented in the UEMS Template structure for the ETR document. The results of the Study will be presented at the Conference. Analysis of acquired information will provide basis for conclusions and strategies to support further implementation of the UEMS training standards in the reality of medical postgraduate training and healthcare outcomes.
