UEMS Office is helping non-EU candidates who passed a UEMS Examination to « authenticate » their UEMS diplomas.

The aims of these doctors is to work in a non-EU country.

For that purpose, we have implemented an administrative process that proves that the document is authentic and has been issued by an officially-registered organisation and signed by the competent legal representative of this organisation.

It has no impact or influence on the content of the document.

Legal importance of the UEMS Diploma in non-EU countries is regulated by local laws and local authorities might be authorised to recognize professional qualifications on the basis of various documents. This does not apply to EU and EEA countries, where recognition of qualifications is governed by the Directive.
