Dear Professor Papalois,

I am writing you as the relatively new Chairman of Board of Transplant Coordination after taking over this position from one of my excellent colleague, Franz Immer.

Firstly I have to ask your understanding because I cannot attend at the next UEMS, Section of Surgery meeting, but please accept my apologies as Hungary will celebrate the 20th anniversary of liver transplantation, so I have to represent the Hungarian donor transplant coordination during this event, which is organized on the same day as the UEMS meeting.

However let me to inform you about recent news or ask your support for upcoming activities. Beforehand let me to mention that I already liaised the following items with Lisa Burnapp, EDTCO president and Beatriz Domínguez-Gil, EDTCO representative in BTC.

1. Presentation at the Competent Authority meeting about UEMS, Board of Transplant Coordination in Brussels, 12th March, 2015

Part of the renewed announcement about BTC and the exam itself, I had a presentation during the last Competent Authority Meeting on Organ Donation and Transplantation which was held at 11-12 March, 2015 in Brussels.

2. Planning the next EBS exam for transplant coordinators

As the next ESOT congress will be organized in Brussels from 13 of September, 2015, I wish to ask your help and support on behalf of the EDTCO president as well to get opportunity to organize the exam for transplant coordinators on the same day as it will be available for other professions under the Division of Transplantation.

3. Election for vacant positions within the Executive Committee

Due to different personal reasons of our previous representatives, currently our Junior Secretary and Treasurer positions are vacant, therefore we are going to open the nomination period, and immediately after that we are going to have election.

I will inform you about the final results.

4. Reinforced advertisement of UEMS, EBSQ for transplant coordinators

4.1 BTC membership

I already wrote request for nomination for those competent authorities from which country we currently do not have active BTC member.

I will inform you about the progress.

4.2 Printed and electronic brochure about UEMS certification for donor transplant coordinators

Another way of promotion to have printed and electronic brochure to summarize the work of BTC and mainly the application process for possible candidates. We are going to have the final version before the next ESOT congress in order to distribute it. And we will ask national competent authorities to put the link on their official websites.

5. Development of the written exam module

We wish to offer the opportunity for all candidates to write the exam on native language, therefore the number of further translation depends on the candidates for 2015. Currently it is available for 9 languages.
