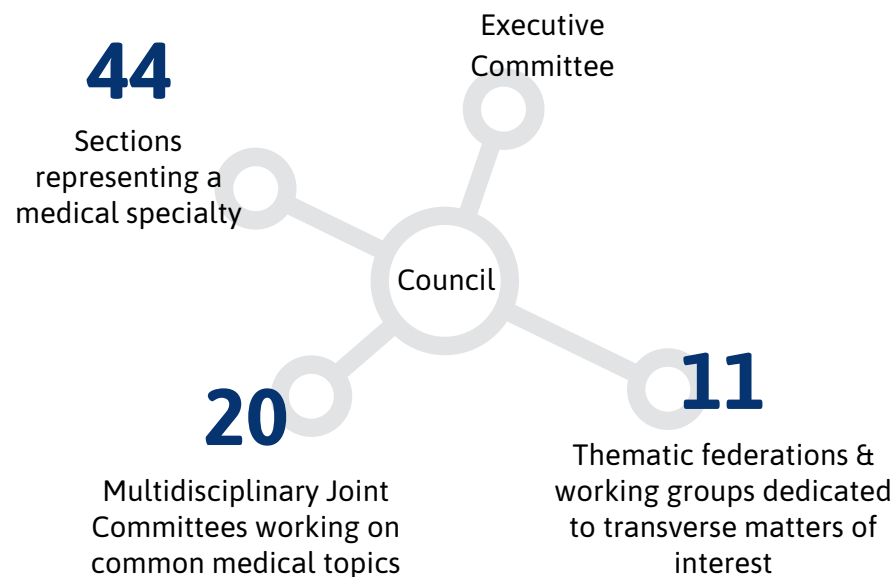
UEMS members are the most representative associations of medical specialists in their respective countries.

## Post-Graduate Training



Develop **European Training Requirements** in **60+ medical disciplines**, setting out the knowledge, skills, and attitudes that a specialist must acquire during their training in order to practice independently and safely.



Organise **European examinations** in **more than 40 medical fields**, to assure high-level standards of the training of medical specialists, and harmonise medical specialists' knowledge and competence.



**Assess & accredit training centres** across Europe to ensure high standards training with optimal environment for trainees and trainers.

## Advocacy

We promote & advocate for free movement of medical specialists, and for the harmonisation of the highest level of training and medical care in Europe.

We support & defend the best conditions of practice for medical specialists, notably in EU funded projects.
