Organisation of the European Board of Surgery

This is not pyramidal but consists of 4 Focus Groups organised in a flat collectivemember driven paradigm. These Focus Groups are the ETR FG, the Assessments and Exams FG, the Recognition of Qualifications FG, and the Engagement of Fellows Focus Group, which is a relatively recent addition. Its objective is advancing involvement of EBSQ Fellows. Each has Coordinator and Members. I am the Coordinator for all the Focus Groups.

How does it work?

Since the structure is not pyramidal but multi- layered and flat, it allows for decisions to be taken at nodes where there is maximal information flow. Networking is done through e-mail in preference to TC (Zoom) Meetings, principally because it gives participants more time for reflection, leading to improved decisions. On site Meetings are held together with the UEMS Section Meetings, twice yearly. Next Meeting is to be held in Malta on the 26th, 27th and 28th of September 2024.
