The "Training Objectives for UEMS Specialists Pertaining to the Care of Adolescents and Young Adults" were officially validated during the General Assembly on 30th April 2022, with the latest version from September 2022 available on the UEMS website: Our structure uems.eu (odoo.com) Supported by EuTEACH, the MJC has developed related tools (slides, videos) that are available on the EuTEACH website. The first draft of the Adolescent Medicine curriculum (module description) was introduced in August 2024 and discussed with MJC delegates and the presidents of EuTEACH and the European Academy of Paediatrics, invited to the MJC meeting in September 2024. Discussion with EUSUHM, IAAH, and UEMO was held in October 2024. Ongoing discussions on Harmonized European Medical Transition Guidelines for Primary and Hospital Care in 2025.

It will take place from July 6th to July 11th, 2025, in Lausanne, Switzerland, based on the training objectives available on the UEMS website. In Greece, there are three active 2-year Fellowship programs in Adolescent Medicine, running in the capital of Athens (2 fellowship programs by the National and Kapodistrian University of Athens) and Thessaloniki (1 fellowship program by the Aristotle University of Thessaloniki). There is also an E-learning program in Adolescent Medicine at the National and Kapodistrian University of Athens entitled "Psychosomatic and Cognitive Development, Reproductive Health, Nutrition, Sports & Adolescent Stress".

The new FEMS board officially began its mandate on January 1, 2025. In these three months, it has defined the new political line and the strategic initiatives it will implement in the coming months:

- Recognition of medical work as arduous work, through an analysis of the current national and European regulatory guidelines and the initiation of a discussion table with European institutions.
- Identification of the fundamental rights of employed doctors, with a particular focus on the union protections for workers.
- Determination of staffing needs through the adoption of the full-time equivalent model for operators.
